HRA Pharma is a privately-held emerging pharma company that engineers drugs, devices and services in reproductive health and endocrinology and makes them available worldwide.

By targeting niche market segments and designing custom-made solutions, our objective is to fill therapeutic gaps. A young and growing company headquartered in Paris, we consider Europe as our home market and our mindset is international.

HRA Pharma makes the difference by combining its health mission with a socially conscious approach to ensuring that its products are accessible everywhere.

Specialty products

The company's products in the reproductive health include hormonal contraceptives, intrauterine devices (IUD) and other products for gynecological use. Norlevo[®], HRA Pharma's first product was launched in France in 1999. It was the first progestin-only emergency contraceptive pill to be approved in the Western world and to be granted a non-prescription status, making it broadly accessible. It is now available in over 60 countries. The company's other products in this field include ellaOne[®], a new generation emergency contraceptive, Gymiso[®], a prostaglandin for use in obstetrics and gynecology, Cicatridine[®] which promotes vaginal healing and Mona-Lisa[®], a copper contraceptive IUD.

In the field of endocrine diseases, HRA Pharma commercializes Lysodren[®] that contains the active substance mitotane. This product has been granted an "orphan drug" status in 2002 and obtained a European Market Authorization in 2004 for the treatment of adrenal cortical carcinoma. It is now commercialized in all the European Union member states. Moreover, in order to assist healthcare professionals in the treatment of patients with this disease, HRA Pharma has developed a European mitotane plasma level testing network called Lysosafe Service. It is a free of charge service permitting to optimize the efficacy of the treatment by adapting its daily dose and controlling patients' tolerance. Altogether, Lysosafe constitutes a very helpful and successful tool for the treatment of this rare and difficult disease.
